Board of Trustees Meeting of June 21, 2023 Action Item Outside Counsel (GL, complex GL, WC, complex WC, school/education) NJSIG No. 0623-09

As a part of NJSIG's efforts to maintain compliance with the PSCL, NJSIG issued requests for qualifications for outside counsel for General Litigation (C-2023-0002); Complex General Litigation (C-2023-0003); School / Education Litigation (C-2023-0004); General Workers' Compensation Litigation (C-2023-0005); and Complex Workers' Compensation Litigation (C-2023-0006). As a result of this competitive contracting process, NJSIG received numerous proposals from qualified firms. These proposals were evaluated using the weighted evaluation criteria.

The designation of a firm as approved outside counsel is not a retention for a specific matter, and does not entitle a firm to be retained for a specific matter. Rather, these firms would now be eligible to handle matters on behalf of NJSIG members. Individual case assignments will be determined by NJSIG based on the unique requirements of each matter. The recommended cutoff for qualifying for the outside counsel designation was as follows:

General Litigation (C-2023-0002): 70 or greater Complex General Litigation (C-2023-0003): 79 or greater School / Education Litigation (C-2023-0004): 80 or greater General Workers' Compensation Litigation (C-2023-0005): 80 or greater Complex Workers' Compensation Litigation (C-2023-0006): 80 or greater

Thus, it is proposed that the firms identified in the attached resolution be designated as outside counsel in the respective areas.
