

# Board of Trustees Meeting June 21, 2023 Action Item Resolution Authorizing the Issuance of Partial Member Refunds NJSIG No. 0623-15

Pursuant to NJSIG Policy 3410, on March 20, 2023, the Board of Trustees approved a partial refund of member contributions from the workers' compensation fund from the 2019/2020 fiscal year, in the amount of \$2,599,938.00, to be performed in accordance with N.J.A.C. 11:15-4.21(d) and paid in proportion to the member's participation in the 2019/2020 workers' compensation fund. The refund amount of \$2,599,938.00 constitutes a portion of member contributions for the workers' compensation fund which is in excess of the amount necessary to fund all obligations for that fund for the 2019/2020 fiscal year.

N.J.A.C. 11:15-4.21(b) provides that "[t]he fund may seek approval from the Commissioner to make initial refund payments from a claims or loss retention fund account remaining from any year which has been completed at least 24 months by submitting a written notification to the Department, with accompanying documentation as set forth in this subsection, at least 30 days prior to the proposed refund. If the Commissioner does not disapprove, in writing, the request to make the refund within the 30 day period, the request shall be deemed approved. The Commissioner may also affirmatively approve the request prior to the expiration of the 30 day period."

Thus, on May 19, 2023, NJSIG sent a letter to the New Jersey Department of Banking and Insurance (DOBI) to advise that we planned to make this refund in accordance with <u>N.J.A.C.</u> 11:15-4.21. On June 19, 2023, NJSIG received written authorization from DOBI approving this refund.

As such, NJSIG requests authorization pursuant to <u>N.J.A.C.</u> 11:15-4.21(b) to immediately conduct the \$2,599,938.00 partial refund of member contributions from the workers' compensation fund for the 2019/2020 fiscal year, as outlined on the distribution schedule by member in the attached resolution.

#### RE: <u>New Jersey Schools Insurance Group ("NJSIG" or the "Fund")</u>

Dear Ms. Deitch:

The Department of Banking and Insurance ("Department") has reviewed the May 19, 2023 filing from the above-captioned Joint Insurance Fund. The Fund submitted documentation in support of approval to conduct "a partial refund of member contributions" on your workers' compensation fund from the 2019/2020 fiscal year in the amount of \$2,599,938.00. To clarify, the Department assumes you are seeking to conduct a partial refund of surplus in proportion to your members' participation in your workers' compensation fund from the 2019/2020 fiscal year.

In accordance with <u>N.J.A.C.</u> 11: 15-4.21, "the fund may seek approval from the Commissioner to make initial refund payments from a claims or loss retention fund account remaining from any year which has been completed at least 24 months by submitting a written notification to the Department". You have indicated "more than 24 months have elapsed since the end of NJSIG's 2019/2020 fiscal year for the workers' compensation fund, which ran from July 1, 2019 to June 30, 2020." Further, you have indicated "the current statutory surplus for the workers' compensation fund for the 2019/2020 fund year is \$19,397,399.00 as of June 30, 2022."

Consequently, the Fund may proceed with a <u>partial refund of surplus of the workers' compensation</u> <u>fund</u> from the 2019/2020 fiscal year in the amount of \$2,599,938.00. Pursuant to <u>N.J.A.C.</u> 11: 15-4.21(d), the partial refund of surplus shall be paid in proportion to the member's participation in the fund for such year. Payment of a refund shall not be contingent on the members' continued membership in the fund after that year.

The Fund Commissioners are reminded that the coverage being afforded by the Fund is subject to substantial volatility in the development of losses. Hence, any monies refunded may have to be returned in the form of a supplemental assessment if such adverse losses develop in the future.
