### ■(NOV-JAN)

The total number of new reports for this period was 1175. This is up 13.6% from a similar period last year. Overall pending was up 5.3% over prior year to date and up 3.1% from last report. Our workers' compensation incoming was down 1.9% and non-workers' compensation was up 24.8% during a similar reporting period from PYTD. This large increase is due to the Hurricane Sandy losses.

#### **■CLAIMS PERSONNEL**

Due to the receipt of over 280 Hurricane Sandy losses we have hired another temp to assist us in processing these property claims.

Giannetto discussed subrogation options with Chesterfield Board of Education on December on December 17, 2013 with their board attorney, superintendent, business administrator and broker.

#### **■**EDUCATION AND TRAINING

Neal Schonhaut completed legal training for the liability staff on December 12, 2012 on offers of judgment and Susan Hodges completed legal training on emotional distress claims (Smith vs. Schmidt) on January 9, 2013. All claims management attended team building offsite on November 26 – 27, 2012. The Claim Department completed training on Microsoft Office 2010. L. Schmidt attended a seminar on How to Deliver Exceptional Customer Service on December 4, 2012 and Developing Emotional Intelligence on January 10, 2013. S.
