Executive Director:

A. Willis Towers Watson Reserve Study

Reserve Study deferred to the November 2019 Board of Trustees meeting.

B. Safety Grant Declaration

Action Taken: M (Russo)\ S (Connors)\ Carried (Affirmative Votes = Sullivan, Quinn, Le Febvre) to accept the Safety Grant declaration of \$2 million, payable in 2023 (bringing that year's payout to \$4.5 million).

C. Wilmington Trust

Action Taken: M (Sullivan)\ S (Russo)\ Carried (Affirmative Votes = Connors, Quinn, Le Febvre) to accept and implement Wilmington Trust's recommendation to move to longer maturities in the investment portfolio.
