We are pleased to report yet another successful renewal season. We welcome our newest Members, Cherry Hill Board of Education, Scotch Plains/Fanwood Board of Education, Camden Pride Charter School and Camden's Promise Charter to NJSIG.

All of the 2015-2016 renewal invoices have been issued to the Membership and the new declaration pages and supporting documentation has been forwarded to our brokers.

The Underwriting Staff responsible for issuing the certificates of insurance once again did a magnificent job, issuing in excess of 2,200 certificates thus far this year.

We are in the process of preparing all of the reinsurance reports for Willis so that they may provide our exposure data and bound premiums to our various reinsurers.

The Client Relations Staff has been very busy meeting with our broker community to discuss their renewal experience and answer any questions they may have.

During the summer the NJSIG Executive Director, Communications Specialist and Client Relations Staff participated in our first ever marketing steering committee with assistance from some of our brokers and business administrators.
