# Board of Trustees Meeting of September 12, 2012 Discussion Item Financial Auditor Review

There are five professional service providers that report directly to the NJSBAIG Trustees. These are financial auditor, actuary, claim auditor, insurance broker, and legal counsel. The attorney has been reviewed by a Trustee subcommittee and a recommendation made for a contract beginning 7/1/2012.

On a rotating basis I recommend a subcommittee of the whole Board evaluate the providers of these services from the perspective of quality and price. This evaluation will help to ensure these service providers continue to provide the professional services required by the Trustees at a competitive price.
