

#### Board of Trustees Meeting of November 29, 2017 Action Item Vision benefits insurance coverage

NJSIG currently obtains vision benefits insurance coverage for NJSIG employees through Vision Benefits of America, and the current contract is scheduled to expire at the end of year. As a part of NJSIG's efforts to maintain compliance with the PSCL, NJSIG solicited a quotation for vision benefits insurance coverage for NJSIG employees. This quotation was compared to NJSIG's incumbent provider of vision benefits insurance coverage for NJSIG employees on the basis of the services provided and cost. Thus, it is proposed that the contract for vision benefits insurance coverage for NJSIG employees be awarded to Vision Benefits of America.
