■(Mar-May)

The total number of new reports for this period was 1264. This is up 24.6% from a similar period last year. Overall pending was up 1.5% from prior year to date and down 1.5% from last report. Our workers' compensation incoming was up 2.2% and non-workers' compensation was down 1.7% during a similar reporting period from PYTD. There are only five (5) Hurricane Sandy cases pending.

■CLAIMS PERSONNEL

Lauren Schmidt has been promoted to Medical Claim Assistant. Congratulations to Lauren. There are currently three open positions in Claims. The Bill Processor which was recently posted, a Senior Claim Representative in Liability and a Claim Representative in Workers' Compensation. William Varley retired effective April 7, 2015 and we wish him luck in his retirement.

■FRAUDULENT CHECK

The fraud check was done for April and May. There were no internal or external problems. We have completed an additional 25 checks in accordance with our direction from the Executive Director.

■ACCOUNT VISITATIONS AND INSTALLATIONS.

Claim reviews were completed at Holmdel and Old Bridge BOEs on March 31, 2015, Union Beach BOE on April 29, 2015 and Elizabeth BOE on May 5, 2015. There were no installations scheduled.

■EDUCATION AND TRAINING

Linda Smith attended an Injury Treatment seminar on April 22, 2015. It was presented by an Orthopedic Surgeon, Pain Management Doctor and Physical Therapist.

■MISCELLANOUS

Workers' Compensation had a settlement day with Freeman Barton on May 14, 2015.

XL completed an errors and omissions claim review on March 18 – 19, 2015. They were again complimentary of the Claim Staff processing of these high exposure claims, especially the handling of coverage.

There were several meetings with Ying Tse, McLarens, on the remaining Sandy claims and Edison fire loss. I met with our property reinsurance companies on April 15, 2015. On April 22, 2015 at the brokers' meeting I discussed the medical only reserve philosophy change that went into effect in February 2015 and that the Claims Department would no longer be handling new errors and omissions losses as of July 1, 2015. Since this presentation we have ascertained some additional information with Group counsel approval. The policy language will be changed to reflect the TPA handling instead of 'the Group'. The TPA will **not** go to the Trustees for settlement authority. We have had preliminary discussion on the following;

- 1. New losses can still be reported via the Accord or the First Report created by the TPA.
- 2. The TPA will use their defense counsel to defend the new claims with the hope that districts can utilize our defense counsel if they request them.
- 3. We will receive copies of coverage letters when coverage is disclaimed.
- 4. The TPA will not ask for contribution on emotional distress claims.
- 5. The districts will still utilize the hotline.
- 6. The TPA will be responsible for doing CMS reporting on new errors and omissions claims.
- 7. Record Only claims reported before July 1, 2015 will be our responsibility.
- 8. Summit will try to abide by our legal guidelines.
- Where there is an errors and omissions file and general liability companion file legal expenses will be shared equally.

Once the above is discussed and finalized we will communicate this information to the districts and brokers.

Tony Jones and I met with Tony Trongone on May 1, 2015. We are finalizing our presentation for the NJASA on May 14, 2015. In preparation for this TEACHNJ presentation Tony Jones and I met with hotline attorney Bruce Padula. Ellen Shaw, Karen Olsen and I are preparing for our "Life of a Workers' Compensation file" presentation for the CAIP meeting on May 15, 2015, as part of the continuous training for our school districts.
