**Introduction for nomination of Thomas F. Connors. Ph.D. to the  
NJSIG Board of Trustees.**

Dr. Connors has been a member of the Piscataway Township Board of Education since 2008. For the past three years, Tom has been the Chair of the Fiscal Planning and Operations Committee. He is also a member of the Policy/ Legislation Committee. He served as the Board's Vice President in 2013, been Chair of Community Relations Committee, and a member of the Curriculum and Programs Committee. Tom has also been a member of the Negotiations Committee representing the board to the Piscataway Township Education Association and the Piscataway Principles and Supervisors Association. Tom has been Piscataway's representative to the Middlesex County School Boards Association since 2011. From 2011 to 2014 Tom served on the New Jersey School Boards' Board of Directors representing Middlesex County.
