The total number of new reports for this period was 583. This is flat from a similar period last year. Overall pending was down 14% from prior year to date and down 8.9% from last report. Our workers' compensation incoming was up 21.1% and non-workers' compensation was up 20% during a similar reporting period from PYTD. There are only three (3) Hurricane Sandy cases pending.

CLAIMS PERSONNEL
